2. DISPOSAL OF SURPLUS FOR FINANCIAL YEAR ENDED 2024

The 48th Annual Delegates Meeting resolved that:

- I) Interest on Members' deposits for the financial year ending December 2024 to be paid to members at the rate of 10.5% on weighted average basis less withholding tax
- II) Dividends on share capital for the financial year ending December 2024 to be paid at 15%.
